AGREEMENT TERMS

DUES & LATE FEE

I agree to pay the monthly dues for the membership selected on page 1. Monthly dues not received within five calendar days of the due date incur a \$5 late fee, limited to one late fee per billing cycle.

CONTRACT CANCELLATION

No-contract memberships may be ended without an early cancellation charge. If I end a 6-month or 12-month contract before its scheduled end date, the cancellation charge is \$50 for a single membership, \$75 for a couple membership, or \$100 for a family membership.

KEY & ACCESS

AS LONG AS YOU HAVE A KEY, YOU ARE CONSIDERED A MEMBER OF THE GYM. YOU MUST RETURN THE KEY TO CANCEL YOUR MEMBERSHIP.

RECURRING PAYMENTS

If I enroll in automatic payments, I authorize recurring monthly charges only through the gym's separate secure payment provider. I will complete that provider's authorization and retain a copy. I may revoke authorization as allowed by law, but revocation does not cancel amounts already owed under a contract.

PAYMENT CHOICES & CARD SURCHARGE

A 3% surcharge applies only to eligible credit-card payments, never debit or prepaid cards, and is subject to provider and card-network rules. With Jim's approval, a 6-month or 12-month membership may be paid in full through Venmo or Cash App. Recurring monthly dues use the gym's secure payment provider.

CERTIFIED TRAINERS

Certified trainers are available only to active gym members. Trainer fees are not included in membership dues and are established directly with the trainer.

CLUB RULES

I agree to follow all posted club rules. Shirts must remain on in all workout areas. Returned-payment or processor fees are separate and will be charged only when disclosed and permitted.
